

2026 World's Biggest Tournament VAR Bonus: Promotion Conditions

1. To participate in this 2026 World's Biggest Tournament VAR Bonus promotion (the "Promotion") you must:
 - a. be a British Columbia or Saskatchewan resident 19 years of age or older, or a Manitoba resident 18 years of age or older, and
 - b. have an active PlayNow.com account.
2. The Promotion will be available from **June 11, 2026 at 12:00:00 am PT / 1:00:00 am CST / 2:00:00 am CDT** and ends on **July 20, 2026 at 11:59:59 pm PT / July 21, 2026 at 12:59:59 am CST / 1:59:59 am CDT** (the "Promotional Period").
3. To participate in this Promotion, you must complete these steps in the following order:
 - a) Register for an account on PlayNow.com or log into your PlayNow.com account; and
 - b) Place a **single wager** on a **Anytime Goalscorer** market on any International Men's Soccer Tournament match during the Promotion Period (an "**Eligible Wager**")
 - c) If the player selected in your Eligible Wager scores a goal that is subsequently disallowed following a Video Assistant Referee (VAR) review, your bet will be paid out as a win, up to maximum of \$1,000.

Example:

If you place a **\$100** wager on Player A to score a goal at anytime at odds of **5.00**, resulting in potential winnings of **\$500**, and the goal from that player is disallowed following a VAR review, your bet will be paid out as a **\$500 Win**, subject to the \$1000 Maximum cap.

 - d) For clarity: Only goals scored and that goal from that player is disallowed during regular 90 minutes plus stoppage time will qualify and the goals scored in extra time or penalty shootouts do not qualify.
 - e) The disallowed goal following a VAR review is as per the **LiveScore** match event information and must be indicated on LiveScore as a 'VAR' event with an X icon, followed by the player's name.

5. Only single wagers placed on the **Anytime Goalscorer** market qualify for this Promotion. Parlays, live/in-play, or combination bets do not qualify.
